FULL DAY SITES

Tuition for full day sites is \$360.00 per month.Students are enrolled for the entire school day.
Early release on Wednesdays.

Extended day enrollment through KidZone (additional fees will apply).

HOW TO APPLY

Please note that acceptance is based on school site availability and state of Florida approval. Enrollment information will be provided upon acceptance into the program.

STEP 1

E

Obtain your VPK Certificate of Eligibility (VPK Certificate/Voucher). **VPK certificates are required and MUST BE SIGNED** by parent or guardian. You can obtain your child's VPK certificate at https://familyservices.floridaearlylearning.com/ You can apply for your child's VPK certificate beginning in January.

Complete the SCPS VPK Ontime Application. To be placed in the lottery, please submit your completed VPK application during our on-time application period February 5th thru March 8th at MIDNIGHT.

*All applications submitted after the on-time application period will be processed on a first come first serve basis.

To be entered into the lottery all applications will need the following:

SIGNED VPK Certificate | Birth Certificate | Lease/Deed | Utility bill | Driver License | Current Immunization | Current Physical

STEP 3

Check your application dashboard for updates on seat acceptance, waitlist information and next steps.

All applications will have 10 days to either accept or decline their seat. **After 10 days the application can and may be moved to the bottom of the list and will be processed accordingly.**

IMPORTANT INFORMATION TO CONSIDER

- All sites are contingent upon enrollment and state criteria.
- Students must be 4 years old on or before September 1, 2024
- You do not have to attend your zoned school for VPK unless indicated above
- Enrollment in VPK does not signify automatic acceptance into the kindergarten program
- · Only completed applications will be accepted
- Transportation is not provided for VPK students, to include SCPS bus services
- All students accepted and enrolled in a full day program will be required to pay a monthly tuition of \$360
